REGISTRATION & TRANSITIONAL FEES FOR ACCOUNTING QUALIFICATIONS 2016 TO QUALIFICATIONS 2022

We're moving to a new fee structure for Qualifications 2022 and away from the membership/subscription model.

Under Qualifications 2022 (Q2022), students will pay a one off fee for access to the qualification for its lifetime, typically four to five years.

To assist and move students onto the new Q2022 qualifications, we've introduced three new transitional fees to allow students currently studying an AQ2016 Accounting Qualification to move to the equivalent Qualifications 2022 level.

To be eligible for this transition fee a student must:

- have an active student membership
- have successfully achieved at least one assessment on the qualification they wish to transfer.

If students meet this eligibility criteria, then they can pay the following to transfer:
